Soil/Soilless/Hydroponics/Compost Tea/Foliar Sprays (per application as needed) ¼ to 1 tsp per gal.

Field Application:

Soil Fertility/Foliar Application – 1 to 2 lbs per acre.

Lawn and Garden: ¼ to 1 tsp per gal.

1 tsp = ½ tbsp = 0.1 oz = 3 grams.
