**Greenhouse & Indoor Production:**

Soil/Soiless/Hydroponics/Compost Tea/Foliar Sprays (per application as needed) ½ tsp to 1 tbsp per gal.

Soil Fertility/Foliar Application – 2 to 10 lbs per acre.

**Lawn and Garden:** ½ to 2 oz per gal.
