2. HAZARDS IDENTIFICATION SUMMARY

KEEP OUT OF REACH OF CHILDREN - CAUTION – May cause mild eye and skin irritation. Avoid contact with skin, eyes, open cuts, or sores. In case of contact, flush with water. Get medical attention for eyes. This blended liquid fertilizer solution is derived from Urea, Dipotassium Phosphate, Ammonium Nitrate, Ammonium Thiosulfate, Monoammonium Phosphate, Manganese EDTA, and Zinc EDTA. Nausea and vomiting could be expected upon large dose ingestion. The acute ingestive effects are described as nausea, chills, and diarrhea. Eye or skin contact with these products could cause irritation (particularly in sensitive persons), and respiratory irritation could be expected from the unprotected inhalation of fertilizer mists. Product users should avoid prolonged or repeated skin contact by wearing impervious gloves, long sleeve shirt, long pants, socks and rubber boots. Goggles for eye protection are recommended. Wash thoroughly after handling and using this product.

4. FIRST AID MEASURES

If in eyes:	Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.
If on skin or clothing:	Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 to 20 minutes. Call a poison control center or doctor for treatment advice.
If swallowed:	Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.

HANDLING:

Wear protective eyewear and chemical resistant gloves. Wash thoroughly with soap and water after handling.

STORAGE:

Store in a cool, well-ventilated area away from heat or flame. Store in original container. Store at temperatures between 41°F and 104°F (5°C and 40°C). Keep tightly closed. In handling system or storage, avoid the formation of solid material from evaporation or salting out. Do not reuse empty container. Do not contaminate water, food or feed by storage or disposal.
