GENERAL INFORMATION

Loveland EQUAL P & K PLUS is a premium nutritional foliar fertilizer designed to supply essential plant food nutrients to crops in a foliar application. Apply Loveland EQUAL P & K PLUS to maximize yield and quality.

DIRECTIONS FOR USE

Loveland EQUAL P & K PLUS may be applied by ground or through sprinkler irrigation. It may also be aerially applied.

APPLICATION RATES

Recommended rates of Loveland EQUAL P & K PLUS vary from 1 to 2.5 gallons per acre as a foliar spray. Consult your Crop Production Services Crop Advisor for proper recommendations and compatibilities.

INCOMPATIBILITIES

Loveland EQUAL P & K PLUS may be mixed with most crop protection products. Do not mix with any calcium-based products (such as Loveland RECOVERY 212 or Loveland CAL-MAX®), or acid or low pH, sulfate containing, sources. Always perform a jar test for compatibility prior to mixing.

FIRST AID

If in eyes: Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

If swallowed: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.
