DIRECTIONS FOR USE:

Used as plant food in agricultural crop production. Apply as needed based on soil tests or according to recommendations in your nutrient management plan.

GENERAL APPLICATION GUIDELINE:

Apply as a foliar application at 1-4 pints per acre or apply directly to the soil at 1-4 quarts per acre.

FIRST AIR

If in eyes: Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

If swallowed: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 to 20 minutes. Call a poison control center or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.

STORAGE and DISPOSAL

STORAGE: STORE ABOVE 52° F. Shake well before using. Store in original containers only. Keep containers tightly closed when not in use. Store in a cool, dry well-ventilated area, preferably in a locked storage area away from children, feed and food products, and seed. Store at ambient temperatures. Do not contaminate water, food, or feed by storage or disposal. DISPOSAL: Do not reuse container. Plastic: Triple rinse (or equivalent), adding rinse water to spray tank, then offer for recycling at an ACRC site (go to http://www.acrecycle.org/ for locations) or by reconditioning, or puncture and dispose of in a sanitary landfill or by other procedures approved by state and local authorities.
