GENERAL: HY-STOP is an acidifier that is to be added to water prior to the addition of pesticides that are subject to alkaline hydrolysis.

DIRECTIONS FOR USE: This product can be used as an acidifier with many insecticide, fungicides, miticides, herbicides, growth regulators, and desiccants. It may be physically or chemically incompatible with some alkaline spray materials. Test on a small scale before using. For neutral pH waters (6.5 to 7), use at least 8.0 ounces per 100 gallons water. For alkaline pH water (above 7 to 8), use up to 16.0 ounces per 100 gallons water. Under extreme conditions (pH above 8), or where a quite low final pH is needed, use up to 32.0 ounces per 100 gallons water.

NOT FOR AQUATIC USE IN WASHINGTON.

STORAGE AND DISPOSAL

STORAGE: Store in a cool, dry place. Store in original container. Keep tightly closed. Do not reuse empty container.

DISPOSAL: Do not contaminate water, food or feed by storage or disposal. Dispose of contents/container at an approved waste disposal facility. Triple rinse (or equivalent) adding rinse water to spray tank. Offer container for recycling or dispose of container in sanitary landfill, or by other procedures approved by appropriate authorities.
