FIRST AID

GENERAL INFORMATION

MULTI-CHE 5N-9ZN is a versatile solution that can be combined with pH neutral solution fertilizers and applied at planting time, side-dressed or by means of irrigation. This product is intended primarily for soil application, however, it can be used in foliar applications as well.

MULTI-CHE 5N-9ZN provides an alternative for use in correcting Zinc deficiencies where low to moderate soil pH's exist and the use of less expensive sulfate forms are not feasible because of incompatibility with commonly used liquid fertilizers.

DIRECTIONS FOR USE SOIL APPLICATION RECOMMENDATIONS

ALL FIELD AND ROW CROPS: Apply 1 to 8 quarts of MULTI-CHE 5N-9ZN per acre in liquid fertilizer blends. The actual rate will depend on crop sensitivity, moisture, placement and plant growth stage.

ALL TREE AND VINE CROPS: Apply up to 6 guarts per acre of MULTI-CHE 5N-9ZN through sprinkler irrigation and not more than 2 quarts per acre through drip irrigation. When application is made through shank equipment, do not exceed 2 guarts per acre.

FOLIAR APPLICATION RECOMMENDATIONS

ALL CROPS: Generally a rate of 1 to 2 quarts per acre of MULTI-CHE 5N-9ZN in a minimum of 20 gallons by ground and no more than 1 quart in 5 gallons by air.

STORAGE and DISPOSAL

STORAGE: STORE ABOVE 52° F. Shake well before using. Store in original containers only. Keep containers tightly closed when not in use. Store in a cool, dry well-ventilated area, preferably in a locked storage area away from children, feed and food products, and seed. Store at ambient temperatures. Do not contaminate water, food, or feed by storage or disposal. DISPOSAL: Do not reuse and seed. Store and antibent emperatures. Do not containing water, lood, or lead by storage or disposal.
